Proposed Acquisition of PNC Infra's SPVs Key Monitorable for Highways Infrastructure Trust

Jan 24, 2024 | Road Assets-Toll | Annuity | Hybrid-Annuity

India Ratings and' Research (Ind-Ra) notes the execution of a share purchase agreement between Highways Infrastructure Trust (HIT; 'IND AAA'/Stable) and PNC Infratech Limited & PNC Infra Holdings Limited (together PNC) for the acquisition of 100% shareholding in the latter's 12 SPVs. The completion of acquisition would depend upon the receipt of relevant approvals and fulfilment of contractual obligations.

HIT proposes to acquire PNC's assets at an enterprise value of around INR90.06 billion, which Ind-Ra and the company expect to be largely funded by raising an incremental debt at the InvIT level and equity from unitholders. Management expects to complete the acquisition in FY25 Ind-Ra will continue to monitor the funding pattern of the proposed acquisition and its impact on HIT's debt coverage ratios. The agency would keep correspondence with HIT's management to obtain more information about the proposed transaction with PNC.

The target portfolio comprises 11 hybrid annuity model-based concessions from National Highways Authority of India ('IND AAA'/Stable) and one Toll road concession from Uttar Pradesh State Highways Authority, and represents around 3,800 lane km in the states of Rajasthan, Uttar Pradesh, Madhya Pradesh and Karnataka. Out of the 12 projects, 10 projects are operational and balance two are under-construction, which will be acquired post commencement of operations.
