The Investment Manager on behalf of The Trust had applied to National Stock Exchange of India Limited ("**NSE**"), to seek its in-principle approval for listing of 70,43,95,456 Units of the Trust proposed to be issued by way of Preferential Issue. NSE by way of its letter dated January 7, 2025 has requested the Trust to amend the relevant date mentioned in the Postal Ballot Notice.

This Corrigendum is being issued to inform the Unitholders about the revision in the relevant date as mentioned in the Postal Ballot Notice.
